AGM Review

Gordon Laxer spoke about his book "After The Tar Sands".

Energy East Pipeline

A coalition of groups: EN, CUSP and ON want equal representation and time to speak to Trans Canada about the pipeline plans. We believe that NOMA should not be expressing approval about the proposal as many NOMA members are not elected officials and the impact is not just on municipalities, but also First Nations' lands, unorganized townships and crown land. Details on construction and maintenance jobs need to be checked. We can see financial trouble as the extra oil will bring the price down and processing the bitumen costs more to produce than the market price reflects. Insurance companies are becoming nervous about insuring pipelines because of past spills and public dissent.

Canada Postal Services

The post offices are looking at a variety of options to keep this service public and viable. Suggestions have been cheque cashing and postal money orders, delivering groceries and checking daily on seniors in the route. Julee will attend the meeting and report back to us.

LPH Green Space

The green space around the old LPH needs to be protected and have more trails. EN will review the status of the city plans for this area.

CJ Articles

Graham's article on the Fort McMurray fire was shocking when the size was overlaid on a map of this region. Many cities have not adapted well to the new climate with more flooding, forest fires and hurricanes.

Roopa's article was on bio-mass. Scott's was about the declining population of woodland caribou and the changing wildlife in this area.

Invitation to Speak

Matawa First Nations are in the 4 rivers area; they are Longlac, Marten Falls, Lansdowne and Fort Hope. This group has invited us to speak to them about general environmental news. Graham will talk to them.
